Christian Santoski & Lynn Giblin Eagle Scout Project

In attendance for this meeting are Christian Santoski, Lynn Giblin, and Steven Walsh.

Christian is looking for a life scout project that would consist of 300 hours of work. He said he wanted a project that years from now it would still be there. **Lynn** said hours are calculated accumulatively if two people work for two hours it counts as four hours to the project. **Christian** will be the manager for this project and the project will need enough meat to show that he can lead the group.

Lynn said this project will have to show Christian's leadership skills so other Scouts will be working on the project with him. Buddy said the area across the street from Bohanon Bridge Road will need a kiosk and a sign at the Cider Mill Brook Trail parking area. The sign would need two posts and routed letters that would stay for a long time, like the signs the state parks have. Buddy said he thinks he has the designs for the kiosks. Jordan suggested benches for the Cider Mill Brook area. Jay said they would like to make some kind of pavilion at the Cider Mill Pond area where people can sit under but it will not be a completely enclosed building, something they can put a couple of picnic tables under. Jay said the parking lot could be designed, posts could be added to designate parking areas.

Buddy said the cabin in the woods (located at the Palmer Preserve) could use a bridge that was equestrian safe. **Christian** asked how much weight that bridge would have to hold. **Buddy** said about 1,500 pounds. The span would have to be about 15 feet. There was some drainage work done on the trail from the cabin in the woods up to the quarry that trail could be extended to Ball Hill Road. **Lynn** asked how long that trail would be.

Buddy said about a half mile. This will only have to be a single track trail.

Buddy said all the trails will need to be marked beginning, end, and intersections. Post holes will need to be dug for the signs and then the signs made and put in place. **Lynn** said digging posts would be an Eagle Scout project on its own: that's a lot of work. **Jay** said the town of Brookline has 20 miles of trails.

Buddy said they purchased the land behind the Sunoco station we just don't know what to do with it yet. **Buddy** said the Cliff Trail at some point could use a railing. **Lynn** asked Christian if he wanted to think about what he would like to so and then come to the next BCC meeting to discuss details. **Christian** agreed.
