#### Minutes

Jay made a motion to accept the public and non-public minutes of the October 25, 2016 meeting. Tom seconded. Vote yes 3-0.

#### Ghost Train Rail Trail Race

**Buddy** said this year's ghost train Rail Race held on October 22<sup>nd</sup> and the 23<sup>rd</sup> and Brookline's half of the proceeds were \$10,001.01. Milford received the equal amount. **Tom** said the race winner Patrick Caron from Needham Massachusetts is getting a lot of attention and he has done a few pod cast videos. This has brought a lot of attention to the Ghost Train Rail Race. **Buddy** said he is 19 years old and ran the ultra 100 mile race in 14 hours and 51 minutes.

#### Conneck Road Bridge

**Buddy** said at last night's Selectboard meeting they agreed to front \$2,000 to AOD Construction (Joel Sanborne) for materials to begin the repairing on this bridge. The whole cost of construction is \$5,400.

#### Taylor Dam

**Buddy** said Matt will need a hand cleaning up around the dam spill way. **Tom** said he may be available. **Buddy** will get the two in touch to set up a day and time.

#### Trail Discussion

#### Trail Cameras

Jay said they have just acquired trail cameras to put out. Tom said he has put a few out.

#### **Hobart Fessenden Trails**

Tom said all the blow downs have been cleared off the Hobart Fessenden Trail.

#### Holbrook Trail

**Tom** said the Beaver Brook Hiking group had walked this trail last week and they put out a favorable review of the trail on their Facebook account

## Sargent Road Bridge

Tom said he hasn't had a chance to go out and move the bridge yet.

#### North End - Hornet Trail

**Buddy** said there was some ATV activity out at the Hornet trail last weekend. There is some trail damage especially around the wetland area. Tracks went from the Hornets Trail out to the Rail Road Bridge. **Tom** said the Brookline Mountain Bike Club has GPS'd that whole area and are willing to improve that bridge if needed.

## Conservation Easement wording for J-16 subdivision Eastman Development, LLC.

In attendance for this hearing Phil Chandler (Owner lot J-16)

Kristen said the easement for the Wildwood Subdivision Open Space lot J-24-33 doesn't look like it has been recorded but the wording is the same as this easement for the new subdivision of lot J-16. Phil said he believes that has been recorded but will look into it. Jay said the way the easement was worded it sounds like once the easement is given over to the Conservation Commission they are required to build and maintain. There are so many different easements all with different wording out there they would like to keep the wording consistent. Phil said they could change the wording if the Board would like. This easement doesn't connect with any town trails at the moment. There is a trail located on the open space lot J-24-33 it just loops around and doesn't connect to any other trails. Buddy said at some point the Board should meet out at the open space lot and walk the trail. He will call Ben Chandler to see if he can meet us out at the property. Tom agreed they should definitely review the property. Phil said the trail is located just after the 4th house on the left from Averill Road. Jay said the Board would like the conservation easements to be consistent. A good example of the easement wording they would like to see is the wording they used for the Hutchinson Hill Estates Development. Jay asked Kristen to find that easement wording and forward it to Phil. Phil said he would pass it along to his attorney to review. Jay asked Kristen to look into weather that first deed was recorded and maybe they can have both easements recorded with consistent language.
