# Minutes Economic Development Committee September 12, 2018

#### **Minutes**

Eddie moved to approve the July 31<sup>st</sup>, 2018 minutes. Seconded by Gerrell. All in favor.

## **Welcome Letter to New Businesses**

Members reviewed the draft letter and made a couple of modifications. All agreed on the final wording. All also agreed on having Tad and Valerie sign the letter on behalf of the EDC.

### **Discuss Potential Halloween Event**

Tad said that he was contacted by one resident about home business owners setting up tables on the front lawn at the town hall while promoting their business. Tad ran the idea by the Selecboard but they were not really in favor of the idea.

The EDC wants to help businesses with exposure but it would be better to have a business event sponsored by the Town. Members discussed other options such as a *Trunk or Treat* event at the Ball Park. It is probably too late for this year but we could discuss it for 2019. Tad will contact the Marianos to see if they would be interested in having a business event at the restaurant once they are open. Pam may also be interested in participating/lunching a business association in Brookline. Such an association would be best for organizing business events.
