Thanks for reaching out. Sorry for the delay in my reply. I was out of the office yesterday afternoon. Yes, we can provide propane service to this location. Looks cut and dry. 2,000 square foot post office, which would need propane service for heat and hot water? Any other fuel burning appliances? Generator? A 500 gallon underground tank would suffice. Typically the propane tank location wouldn't be drawn into the site plan, but you could put it on there if necessary. Most times, we decide where it is going on site with the site contractor once work has commenced. At first glance, it looks like the best location would be behind the building on

either side of the leach field, or the right hand side by the septic tank. The propane tank would need to be a minimum of 10 feet off of the structure, and there is no setback from the leach field or septic tank. I have attached a pdf of our tank dimension information for you to reference.
