Minutes Board of Selectmen Monday, March 7, 2011

Selectmen Linda Saari, Clarence Farwell, Kevin Gorgoglione and Jack Flanagan were present.

Public Input - Police

Betty Hall asked how the numbers were arrived at in the statement that Linda read last week. She asked where the \$22,700 that we are saving because of Quigley's receiving his pension and not paying into the retirement system came out of the budget. The selectmen explained several times that the figures contained in the \$22,700 noted in the Statement (NH Retirement, Medicare, Health, Dental, Life, Short Term Disability, and Long Term Disability Insurance) were never in the proposed budget. Rena noted that she met with Betty last week to go over the numbers and that Tad would be back on Tuesday for her to speak with him. The police budget was the last to be reviewed so the new chief could present it. Linda said the selectmen are still trying to get things worked at with the NHRS.

Jack said he feels the police department is better run than it ever was in the past.

Brusch Hall -AED (Defibrillator)

Sheryl Cory said the Firefighters Association wants to put a defibrillator in Brusch Hall. She said she talked to Wes Whittier about training the senior citizens on how to use it. *Clarence moved, seconded by Kevin to accept the Defibrillator to be placed in Brusch Hall. Voted yes 4-0.*

Town Meeting

Moderator **Peter Webb** was present to review the warrant with the selectmen. He said he has to be in court for a portion of the afternoon and has sworn in Loring Webster to fill in for him. Jack and Kevin said they would be at the polls at 7 am. Clarence will arrive at 8 am and Linda will be there from 3 to 7:30 pm.

Personnel Hearing

The Selectmen authorized the posting of a personnel hearing at the town hall for Friday, March 11th at 3:30 pm.

Non Public Session

Linda moved, seconded by Clarence to go into non public session under RSA 91-A, 3, II, (d) to discuss the acquisition of property. Voted yes 4-0.

On returning to public session, Linda moved, seconded by Clarence to seal the minutes. Voted yes 4-0.

Transfer Station

Linda announced the electronics collection is Saturday, March 12th.

Rumore Way

Kevin said the planning board met with Keith Adamyk about 5 issues on the Rumore Way subdivision:

- 1. The granite sign is broken. The PB said since it's been fixed it doesn't have to be replaced.
- 2. At this time of year it can't be determined whether the grading has been done but Keith doesn't have to do anything more.
- 3. The granite bounds will be set.
- 4. The silt fence will be removed.
- 5. Keith will either fix the culvert and submit an as built plan or build it according to the subdivision plan and will work with Dennis LaBombard on this issue.

These issues will be address by May 19th or a bond will be required.

Linda thanked Kevin for all his work on the selectmen and planning board. Kevin said he talked to the planning board about being an alternate.
